#### 4. FIRST AID MEASURES

**General Advice:**

## 6. ACCIDENTAL RELEASE MEASURES

<b>Personal Precautions:</b>	Use personal protective equipment. Avoid substance contact, ingestion and inhalation. Ensure adequate ventilation. Mark out the contaminated area with signs and prevent access to unauthorised personnel.
<b>Environmental Protection Measures:</b>	Do not allow to enter sewerage system.
<b>Small Spill:</b>	Wear personal protective equipment. Use appropriate tools and adsorptive material to contain and adsorb the spilled solution and dispose of in a convenient waste disposal container.
<b>Large Spill:</b>	Use appropriate tools and personal protective equipment. Stop leak if without risk. Do not touch spilled material. Prevent entry into sewers, basements or confined areas; dyke if needed. Absorb with liquid binding material like sand, universal binders. Call for assistance on disposal.

## 7. HANDLING AND STORAGE

<b>Handling:</b>	Handle with care in accordance with good industrial hygiene and safety practices. Avoid inhalation of mist. Avoid contact with eyes and skin and any form of ingestion. Wear suitable protective clothing such as overalls, boots, rubber gloves, goggles, nose and mouth protection and wash contaminated clothing daily. Wash thoroughly with soap and water after use or accidental skin contact. Do not eat, drink or smoke during use. Avoid contamination of food, foodstuffs, eating utensils and drinking water. Do not discharge residues or any of the product into rivers, dams and canals.
<b>Storage:</b>	Store in a cool, dry and well ventilated place away from food, foodstuffs combustible materials and incompatible substances. Close container tightly after opening. Store under lock and key and keep out of reach of children, uninformed persons and animals. Access to water and eye wash facility should be available.
